ANNOUNCEMENT

NEW EU RESEARCH PROJECT

We are pleased to inform you that our project *An indirect harmful effect of violence: Victimization of the child and Re-victimization of the woman-mother through her child's exposure to violence against herself*, submitted under the 2008 DAPHNE III call for proposals for action grants, has been selected for co-funding by the European Commission. Applicant of the project is the University of Cyprus- UNESCO Chair in Gender Equality and Women's Empowerment, and specifically Prof. Mary Koutselini, Department of Education. The partnership of the project consists of three partners of the UNESCO Chair's Partnership (Università di Roma Tre, Italy - Leader: Prof. Sandra Chistolini, University of Presov, Slovak Republic - Leader: Prof. Iveta Kovalcikova and University of Oradea, Romania - Leader: Prof. Secui Monica) and fifteen associate partners (GOs and NGO's) in the participating countries.

This project has a twofold aim: Firstly, to address the problem of the indirect harmful effect of violence against women and mothers upon their children if exposed to it in the domestic sphere, as well as mothers' conscience of that effect and secondly, to address the problem of lack of research based information on the issue as well as of sensitization. This will be reached by: a) data collection for mothers' awareness about the indirect harmful effect of violence against them upon their children if exposed to it, b) investigation of possible indirect harmful effect on children and comparison of their perceptions and self-images with children not exposed to violence against their mother, c) production of research-product guidelines for the development of informational, web-based counseling, TV broadcasting and educational material, d) the web-paged sustainable communication and counseling, and e) multi-level dissemination of the results.

The project is innovative as content and methodology is concerned and its results can contribute to the current EU policy areas regarding the indirect harmful effect of violence against children.

Voting will close on May 10th 2010. The outcome of the election will be announced at the CiCea Association Annual General Assembly in Barcelona on May 22nd 2010.

If you are considering standing, you may want to start preparing your statement and ensuring that you have two proposers who are members of the Association this current year.

The main goal of the research is to compare experiences of peace education before and after 1989 in Finland, Lithuania and Sweden, in three countries with different historical and cultural backgrounds and what "Peace Education" means in different cultural, political, social, contexts.

The research starts in 2010 January and is expected to be finished by 2011 June (18 months period).

**“Once upon a time there was a wall...”:
Historical narrations in a TV documentary**

On the occasion of the conference of the School of Balkan Studies in Florina concerning the 20th anniversary since the fall of the Berlin Wall, which is taking place on the 16th-18th of October, we are going to present a paper about a TV documentary focusing on real stories about people who escaped or tried to escape from Eastern to Western Berlin. The documentary was produced by the National Greek Television in 1999, ten years after the fall of the Berlin Wall and consists mainly of interviews and material from the Eastern Germany propaganda. The documentary has a “western gaze” towards the Wall, focusing on the irrational phenomenon of the division of Berlin in half and the impact on people’s everyday lives. Our basic aim is on one hand to analyze the documentary’s historical narrations using semiotic analysis, which is suitable for the analysis of TV texts, and on the other hand to propose ways in which the documentary could be used in the educational process, according to the principles of media education.

Analyzing the specific documentary we focus on the opportunities for citizenship education that are very much depending on the educational background and the social context young people live in. The reality of deprived areas and the gap between concepts and practice have to be regarded while thinking about methods and instruments for citizenship education.

**Greek Urban Folk Music (1934-1938):
The representation of gender in Rebetiko**

In the field of Cultural Studies, our research focuses on detecting the representation of gender in Greek urban folk music called Rebetiko. The period we researched is between 1934 -1938, called “the Classical period of Rebetiko”. Concerning the social and the political context of this period, we refer to the uprising of capitalism in modern Greece and the dictatorship of Metaxas with the imposed censorship. From this period we take Rebetiko songs and we analyse them by using Semiotics.

Our method of analysis is Greimasian structural semantics. We analyze the lyrics of the songs in order to find out the stereotypes on the representations of gender. We locate isotopies and create the paradigmatic and the syntagmatic axes. The results show that Woman is mostly represented by the external characteristics of her sex and also her behaviour. Her beauty, combined with her manners, provokes men and positively or negatively determines his feelings. Women use their sexuality as an instrument to impose themselves on the sentimental world of men. We conclude that this way of representation is negative and lowers women by not taking under consideration other aspects of her personality.
